WE CONDUCT A PERIODIC SALARY REVIEW USING THESE SAME BENCHMARKING SURVEYS. ANNUAL INCREASES TO ADJUST FOR COST OF LIVING INCREASES ARE DETERMINED BY A COMBINATION OF CONSUMER PRICE INDEX ACTIVITY AND AVAILABLE ORGANIZATIONAL BUDGETING.
