### **GENERAL NEED TO KNOW**

- Seeding Fractals will be an in-person event in Washington, DC from Wednesday April 9-Friday April 12 with curated programming from session proposals on Wednesday April 10 and Friday April 12.
- Each session is an hour and 15 minutes long.
- Each scheduled session will receive a \$100 honorarium.
- Once you have been selected, the Guild will schedule a time to connect about your application to share best practices and confirm your date and time.

- We are seeking session proposals for our Wednesday April 10 and Friday April 12 conference dates.
- Proposals will be reviewed by a scoring scale detailed in page 5.
- All communication will be sent to the session contact.
- Headshots and bios for all speakers should be ready before submitting.

### Appears on the website, app, and program book —

#### Session Title (15 word limit)

Your proposal title should be both clear and intriguing, providing a hint of the information participants will gain while also sparking their curiosity.

#### Session Description (50-100 word limit)

Your session description is a short summary that outlines the content, objectives, and key takeaways of your presentation or workshop.

#### **Program Tags**

To help us curate the best experience for attendees, we ask that you choose up to 3 program tags that best align with your session.

#### **Session Format**

Tells us the format of your session to help us curate and plan for your session.

- Workshop: Hands-on learning experience involving audience participation, skill-building, and problem-solving exercises.
- Program Showcase: Demonstration of an exemplary program, with an experiential learning component.
- Lecture: Dynamic presentation of new information, research, and/or insights.
- Fractal Conversation: Facilitated discussion centered on a question or topic
- DC Site Visit with workshop (Friday April 12 9am-12pm)

#### Headshot & Bio

Headshots and bios will only be used to post on the website after your session has been approved. They will not be used during the session review process.







## **PROPOSAL GUIDELINES**

#### What we will use internally to understand your session -

In order to better understand how your session aligns with our conference, we will ask that you complete the following:

#### Session Objective (50-100 word limit)

The session's specific knowledge, skills, or insights that participants will gain from attending the session.

#### **Our Four Guiding Questions**

We will ask you to answer our four guiding questions that we will use to determine if the session proposal aligns with our intentions for the conference.

- 1. How is your session using a creative component or creativity as a radical way to center equity? (200 word limit)
- 2. How was community engaged in a reciprocal and sustainable way? (200 word limit)
- 3. How does the content radically support a lasting positive impact on the field of community arts education for intergenerational communities that have been and are systemically marginalized? (200 word limit)
- 4. What are accessibility considerations that will be used during the session? (200 word limit) We ask that you outline any accommodations, materials, or technologies you intend to use to ensure that all participants can fully engage and benefit from your presentation.







## THE RUBRIC

Inspired by the life cycle of a plant, our proposal review process acknowledges that while each stage in the life cycle is important, we would love to pollinate our community with blossoming ideas from our changemakers. Each stage is being represented by a rating scale from a range of 4 (blossoming) to 1 (sprouting). Proposals are carefully reviewed to ensure its content is accessible, clear, creative, engages the community, and creates a lasting impact on the field of community arts education with and for communities that have been and are systemically marginalized.

### Seedlings

- The intention of creativity and equity is lightly mentioned.
- Community engagement is present but based on a traditional transactional model.
- Some intentions to create a positive impact on the field of community arts education for communities that have been and are systemically marginalized.
- Intention of accessible content is present but with significant gaps.

## THE LIFE CYCLE

- Budding
- Content has some creative and innovative ideas that are clearly stated as equitable.
- Community engagement is good, reciprocal and may be sustainable.
- The content has radical ideas that can create a positive impact on the field of community arts education for intergenerational communities that have been and are systemically marginalized.
  - Most key accessibility considerations are acknowledged with some gaps.

#### Blossoming

- There is strong and clear creative content with innovative and equitable goals.
- Community engagement is strong and clearly stated based on a reciprocal and sustainable model.
- The content contains clear and strong radical ideas that have a lasting positive impact on the field of community arts education for intergenerational communities that have been and are systemically marginalized.
- All aspects of accessibility are thoroughly addressed for diverse learner and disabilities populations.
